Planned Giving "103"

You may donate as much to a charitable organization as you see fit, but the Internal Revenue Service (IRS) has set forth rules which limit the amount of your charitable donations which you can take as a deduction, generally up to 50% of your adjusted gross income, although it could be lower depending upon the type of charity and the type of property which is the basis of the deduction.

More importantly, since most people do not reach the 50% limit, there are specific IRS rules which must be followed for any contribution to be deductible, and for your contributions to sustain the scrutiny of a possible IRS audit. These rules include appropriate substantiation of the donation, which can be accomplished by keeping detailed and accurate records of your gifts. Monetary contributions are the easiest to keep track of, especially if the donation is made by check or credit card. If a donation is made in cash you should request a written receipt from the charity, indicating the date and amount of the contribution, and full contact information about the charity.

For donations of personal property, you might be best served by taking a photo of the item to be donated, gifting it together with a transmittal letter detailing the donation, and requesting a receipt which specifically describes the item, in addition to the items set forth above. It would also be helpful to obtain, and retain, a good faith estimate of the value of the property being donated. If you are audited, the length of time between the donation and the audit may make it difficult to obtain a worth while estimate, whereas an estimate obtained contemporaneously with the donation will be difficult for the IRS to decline.

Wear Proper Safety Equipment When Biking

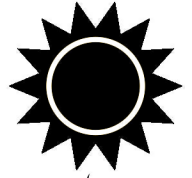
Head trauma is a biker's most common major injury. A properly worn helmet can prevent it by up to 85%. Wear bright colors so drivers can see you.
